PERSONAL ASSISTANT SERVICES are a self-directed service* offering personal assistants on a one-to-one basis to ensure the health and welfare of the individual. Support with the tasks the person would typically do for themselves or by themselves, if they did not have a disability. Such services occur at home or in the community assisting the individual. Services might include direct assistance with health care needs, self care activities or tasks promoting independence, productivity, and community integration. Personal Assistant Services is available to individuals who live in one of the following settings:

- Individual's own home or apartment
- Individual resides with someone meeting the definition of family
- A setting where a child, 5 to 21 years of age, is in the custody of SRS but not living with
- A setting in which a child, 15 years of age or older, resides with a person who does not meet the definition of family and who has not been appointed the legal guardian or custodian
